- The drawing will take place on **Sunday, December 18, 2022**. Need not be present to win. Winner will be notified by phone and/or mail.
- This raffle is subject to all applicable federal, state and local laws and regulations.
- Catholic Social Services shall make all decisions related to the raffle in its sole discretion. By participating, you agree to be bound by these Official Rules and the decisions of Catholic Social Services and waive any right to claim ambiguity in the raffle operation or Official Rules.
- By participating in the raffle, you agree to release and hold Catholic Social Services and its directors, officers, employees and agents, harmless from any losses, damages, rights, claims, and actions of any kind in connection with the raffle, including from your winning or use of the prize.
- The IRS has taken the position that amounts paid for chances in raffles for valuable prizes are not gifts, and consequently do not qualify as deductible charitable contributions.
- All net proceeds go to support the programs of Catholic Social Services.
- Catholic Social Services reserves the right to either void tickets purchased with invalid funds (e.g., checks that do not clear when first deposited) or allow the purchaser to provide valid funds at least five business days before the raffle drawing, with related costs covered by the ticket purchaser.
- The winner of the raffle will be asked to complete IRS Form W-2G prior to claiming the two Nebraska football season tickets.

- Ticket cost is one for \$20.00 or three for \$50.00. More than one person may share in the raffle ticket purchase.
- If for any reason the raffle is cancelled, Catholic Social Services will reimburse each raffle ticket purchaser within sixty (60) days of the raffle cancellation date.
- Due to postal regulations, raffle ticket stubs cannot be returned by mail for purchases over the internet, through the mail or by telephone. However, a receipt of your purchase with ticket number will be sent to you via U.S. mail. **Mail orders must be received by Saturday, December 17, 2022** in order to be included in the raffle drawing. When an order is placed, we will complete the ticket by filling in the name, address and phone number and we will drop the ticket in the barrel for the drawing. At the drawing, the winner, if not present, will be notified based on the name and information on the ticket. To claim the \$5,000.00 prize, two forms of identification, one of which must be a photo I.D., will be required to prove that this person is the person on the winning ticket. Tickets must be paid by cash, check or debit card.
- Successive alternate backup winners will be drawn and held by Catholic Social Services in case the first winner does not claim the grand prize in 90 days or is otherwise ineligible.
- Employees, board members, officers and agents of Catholic Social Services are eligible to participate in the raffle.
- Retain your ticket stub if you purchased the ticket in person, or your receipt with ticket number that you received if you entered the raffle through the mail. In the event of any dispute or controversy concerning the winner of the drawing, you will be required to produce your raffle ticket stub.
- Catholic Social Services will pay the required federal regular gambling withholding tax equal to 33.33% of the fair market value (FMV) of the prize less the amount of the wager. Catholic Social Services will pay the required Nebraska withholding tax of 5%. Any and all other taxes are the responsibility of the winner.
